Paul circulated the summary of accounts sheets which were reviewed. Income was mostly due to payment of subscriptions, Outgoings exceeded income by £2k mainly due to track hire bills.

Increases in hire of Rugby track and probably Sixfields track will impact on the amount of money available for expenditure on projects in 2012.

Subscriptions for 2012 -13 were reviewed with an overall increase of 5% agreed Family membership was reviewed in detail and it was agreed to raise family membership to £190. Family membership was up to three members of the same family (no requirement for an adult) with additional family members priced at £25 per person.
