- Election of Honorary Officers

Any member who is age 18 or over on 18 March 2019 and is a fully paid-up member may stand as a candidate for any of these posts of Honorary Officer. (Parents of junior members are eligible to stand only if they are also Club members themselves.) Candidates must be nominated by two other members (proposer and seconder). Nominations must be sent to the Hon. Secretary no later than 21:00 on

Monday 11 March 2019 (a hard copy with the signatures of the proposer and seconder may be requested).
